Be kind and respectfull, also when you don't agree

- Offensive, misleading, alarmist, illegal, or inciting illegal activities, political or propagandistic violent or pornographic, incorrect or aggressive contents will not be tolerated. Furthermore, sexual harassment or other behavior that may offend people's feelings or undermine the dignity of individuals and institutions, the rights of minors and the principles of freedom and equality will not be permitted;
- Discriminatory and intimidating content based on gender, race, ethnicity, language, religious beliefs, political opinions, sexual orientation, age, personal and social conditions is not permitted;
- Content that violates copyright or uses trademarks without permission are not permitted.

Stick to the topic of the conversation and contribute to the dialogue

- Off-topic contents and comments (OT), out of contest or that involve spam or promotional messages will be carefully moderated;
- Posts from fake or anonymous profiles will be deleted as soon as they are identified;
- Comments and posts written with the aim of disturbing the conversation or offending the people who manage and moderate the social channels will not be accepted;

 law or this Social Media Policy. Moreover, it reserves the right to delete or block (after an initial
 warning) accounts that repeatedly violate these conditions to prevent further interventions, as well
 as to report them to the platform managers and, as a last resort, to the authorities in charge of law
 enforcement.

Protection of the privacy
